6) I have read and understand the campaign finance provisions set forth in Pitkin County Home Rule Charter ("HRC") § 6.6, including without limitation the following provision:

No person shall make a contribution in an amount which exceeds five hundred (\$500.00) dollars to any candidate, or to any political committee making coordinated expenditures for the purpose of supporting or opposing the nomination, retention, election, or defeat of any candidate. All political committees shall comply with all organizational and filing requirements of the Colorado Fair Campaign Practices Act, as amended. All candidates in any

election shall designate any political committees affiliated with, or known to be making expenditures in support of, the candidate's campaign.

Additionally, all political committees shall submit an affidavit of organization demonstrating decision making independence from any candidate or other political committee. Affidavits of decision making independence must be filed with the County Clerk. Any political committee not filing such an affidavit may not collect or expend money or contributions in kind in support or opposition of any candidate. The County Clerk shall publish the names of all candidates and political committees not in compliance with the election provisions of the Charter no later than ten (10) days prior to all elections." (HRC § 6.6.2)

7) The Political Committee has decision making independence from any candidate for elective office in Pitkin County, Colorado and from all other political committees supporting or opposing such candidates.
