Candidate petitions must be filed with the Pitkin County Clerk and Recorder Election Office not earlier than **Monday, April 11, 2022** (20 days prior to SOS ballot certification), nor later than **Friday, April 22, 2022** (5 days prior to SOS ballot certification), as established for the deadline by the State Statute for Secretary of State (SOS) to transmit to each County Clerk and Recorder the notice of primary election.

- All petition sections must be submitted at the same time in order to review and determine sufficiency.
- It is encouraged that petition sections are submitted in a timely manner to allow a candidate more time to collect additional signatures before the deadline, 5 days before certification, in the event that the petition review is not found sufficient.
